

# SCSEP GPMS

## Release Notes – Version 1.6

---

**Release Date: March 17, 2023**

The GPMS Release 1.6 will address new features, Production data changes and bugs discovered during the previous release.

### New Features and Enhancements

- The **Nationwide QPR, Follow Up, and Participants Action** reports are now available for users to view and download.
- The links to the Frozen QPR, Internal QPR (WIPS), and Internal QPR addendum (WIPS) have been disabled until the functionality is developed.
- Read Only users can now view Paid Hours for Grantees/Sub-Grantees.
- Users will no longer receive a task to end an approved break if the participant has exited the program.
- The **Submit and Create Case** button on the **Manage Re-Enrollment** screen is renamed **Submit**
- The **Agency Type** label on the **Add Organization** page is relabeled **Organization Function**
- The search function for Host Agency is no longer case sensitive and partial names can be entered in the search field.
- Sub-Grantee TN328 has been deleted from the system.
- The duplicate entry for Sub-Grantee MN017 has been deleted from the system

### Fixes

- Users can clear tasks for Training services end date and Offer of Physical exam
- Addresses issue with some users receiving UI Error when doing a Participant search.
- Addresses issue with task not closing when a Participant is Exited and Approved Break is ended/closed
- Addresses issue with user unable to clear Tasks related to Training and Services that have ended
- Addresses issue with user unable to clear Eligibility Task once the participant has been determined Eligible
- Addresses issue with user unable to clear Tasks related to Offer of Physical Exam
- Addresses issue with values entered for Ethnicity Hispanic/Latino, Race, Most in Need Waiver Factor, and Other Characteristics not copied when the case is transferred
- Removed **Add Placement** button for any **Other Reason for Exit > Exclusions at Exit**
- Cleaned the duplicates created in Production for Follow-Up data
- Added transferred date from migrated data to Participant Extracts

- Production Data corrections for specific grantees and cases. BCT will reach out to the specific grantee for validation of these changes in Production.

## **Known Issues**

- **Participant Actions Report**
  - The report does not run for larger grantees (UI error)
  - We have identified issues that impact the presence of safety consultation records on the report. If you see records that do not align with the host agency a person is currently assigned, please let us know.
- **Follow-up Report**
  - We have identified issues that cause records where placement end date is valued to be omitted from the report in error. A fix will be instituted on the next release.
- **Quarterly Progress Report (QPR)**
  - We have identified issues that impact the counts and rates on the nationwide QPR in sections B, C and D. Measures that we know have been impacted include:
    - Employment Rate – 2nd Quarter after Exit
    - Employment Rate – 4th Quarter after Exit
    - Median Earnings
    - Number of Placements
    - Number of Records Without a Placements in the Second Quarter After Exit
    - Percentage of Placements in the 2nd and 4th Quarters with the Same Employer
    - Total Number of Hours Worked in Community Service
  - We anticipate these issues will also impact the grantee, sub-grantee, and state QPRs as well. We will be implementing fixes in upcoming releases to address these. If you have questions or issues with any other measures on the QPR, please contact the BCT team and we will investigate further.
  - Please note the QPR data is still under development and should not be considered final.
