Release Notes – Version 1.7

Release Date: April 21, 2023

GPMS Release 1.7 will address new features, Production data changes and bugs discovered during the previous release.

New Features and Enhancements

- The Waiver of Durational Limit (WDL) report is now available for users to view and download.
- All user roles can now delete an **Exit** (except for transferred cases) regardless of the date of exit. The status of the record will change to **Active** after the **Exit** is deleted.
- Global Read Only users can now view the Authorized Position in the Admin Console → Manage Authorized Positions.
- The IEP/ Assessment Date on the Assessment/IEP details form is now required if Days Left is less than or equal to 365.
- The Add Participant search card is now added to the Admin Console for the Program Analyst role.
- Added a comma (,) after e.g., in Work Related Assistance (e.g., Uniform, Badges, Tools) in **Type** from the **Category** dropdown in **Supportive Services**
- Changed the label on the Add Assignment screen from Supervisor's Starting Wage per hour to Supervisor's Wage per Hour.
- Added an Introduction paragraph for the Follow-Up Report
- Added default filters to the Follow-Up Report before selection criteria is applied.
- Removed Title as a required field on Contacts.
- Added County of Residence to the Cases tab.
- Added an additional dropdown field labeled Salutation to the New/Contact Form under New Survey/Contact link.

Fixes

- Additions and updates to Secondary Contact data is now saved in the system.
- Addresses the adjustment to Section C: Total Participants Served, on the Nationwide QPR when an individual is transferred. The measure should remain unchanged.
- Data entered on the **Application Certification Section** is now retained.
- The Equitable Distribution (ED) report for PY22 now reflects the Authorized (AP) and Modified (MP) Positions.
- Fixed sort issues with participants' last name in Manage Paid Hours console.
- Fixed the incorrect **County of Residence** displayed on the **Current/Exited Report** detail.

- Fixed the issue where **Days Left in Program** and **Months Left in Program** were not displaying correctly when a participant's status changed.
- Fixed the issue where participants did not appear in search results if the participant is assigned to a Grantee Admin when no Case Manager is available.
- Users will no longer receive emails for Task and Notifications
- Fixed an issue where **Months in Program** was displaying incorrectly in **Recertification** for certain participants.
- Completed Assessment/IEP Tasks have been cleared for users.
- Fixed an issue where some users were receiving a UI error when selecting a Sub-Grantee from Grantee → Related Actions → Manage Grants.
- Fixed an issue where a case was displaying multiple/duplicate Assignments in Participant History that did not appear in the Assignment tab.
- Resolved an issue where Grantees who do not provide extensions were receiving tasks to provide participant extensions.
- Fixed issue where deleted Assignments were still appearing in Participant History and Training/Service records.
- Fixed an issue where Ineligibility reason at Recertification was not saving.
- Resolved an issue where Assignments added to migrated cases, the Veteran, Post 9/11 Era field was grayed out and displayed an error.
- Removed the unknown grantees appearing in the list for Grantee Extracts.
- Corrected heading for column L in the PRA report extract file. Column L heading is now labeled **Date_of_Recertification**.
- Fixed the issue where Date/Timestamp on Eligibility screen is automatically changing to the previous day.
- Resolved an issue where the placement was not appearing on the Follow-Up report when a placement end date was present in the system.

Known Issues

Issues introduced from deployment of release.

- Waiver of Durational Limit Report
 - Export functionality yields an error or exported report has only one row.
- Follow-up Report
 - The export functionality does not work.
