SCSEP GPMS

Release Notes – Version 2.0

Release Date: August 25, 2023

GPMS Release 2.0 will address new features, Production data changes and bugs discovered during the previous release.

New Features and Enhancements

- Related Actions → Manage Paid Hours will now function across Program Years. Users now can add/view hours for previous Program Year as well as current.
- EOY (End of Year) is now available for Internal and Nationwide QPR in Quarter drop down choices (7/1/xxxx-6/30/xxxx).
- QPR Freezing functionality. GPMS now features the ability for Program Analysts to freeze quarterly Internal QPRs. Once QPRs are frozen, users will be able to view frozen QPRs.
- Read Only and Read Only Restricted roles can now generate Internal and Nationwide OPRs.
- Users will now receive a Task when an IEP/Reassessment is due for a participant.
- ED Reports are now sorted alphabetically by state and county.

Fixes

- Manage Organizations and Contacts search function will no longer return multiple contacts; users can also switch primary and secondary contacts.
- Durational Limit exit reason cannot be selected prior to Durational Limit date.
- Follow up completed dates are now populated in Follow up Report display.
- Updated message "Waiver Factors and Last Updated Dates can be updated from the Related Actions tab". Corrected capitalization issue.
- Fixed formatting issue of Section D of QPR.
- Nationwide QPR goals will display "blank" if no values are entered or removed.
- Fixed issue with ending an Approved Break on "today's date" Add Assignment is not available.
- Fixed requested participant data changes.
- Fixed issue regarding deletion of Assignment with Training/Services records still appearing in Participant History.
- Fixed issue with users receiving error message if previous Assignment End Date and new Assignment Date are the same.
- Outstanding Task Type: Reassessment has been removed for participants in Withdrawn, Waitlist or Exited status.

- Fixed issue with GPMS using Approved Break Expected End Date to generate error message when attempting to add a new Assignment.
- Fixed issue with deleted Exit appearing in Cases tab and Participant History.
- Fixed issue with status Active-On Break appearing after Approved Break has ended.
- Fixed formatting issue in ED detail report.
- Fixed issue with deleted PIDs/Cases appearing in Admin Console > Participant Search.
- Fixed issue with Grantee name appearing in Sub-Grantee drop down. Program Analysts can now add Grantee Administrator role.
- Users can no longer select "Yes" values for both Limited English Proficiency and Low Literacy in GPMS.
- Fixed issue with Program Analysts receiving an error when attempting to activate/deactivate users.
- Fixed issue with Program Analyst's ability to edit Date First Active for Grantees.
- Fixed issue with QPR Section D execution procedure.
- Fixed issue with Modified Slots not appearing on ED Reports for PY22 Q1.
- Fixed issue with termination letter date entry; field can now be entered independent of other exit data and edited if necessary.
- Resolved error on Characteristics tab regarding Low Literacy and Low Employment Prospects when user selects Save + Continue.
- Grantees/Sub-Grantees Active/Inactive flag is now auto-updated based on Date Last Active.
- Fixed issue with incorrect variance calculation on ED Report.
- Fixed issue with users' ability to select both "None" and other Benefits selection when adding a Placement.
- Fixed issue with inaccurate numerator/denominator values in section B2.2 Employment Rate (Q4) of the QPR report.
