Release Notes - Version 2.8

Release Date: August 2, 2024

GPMS Release 2.8 addresses new features, enhancements, and bug fixes discovered during the previous release.

New Features

- Right of Return can no longer be completed with an open placement. The placement end date must be entered in order for the system to compute the time-in-placement correctly.
- If a user attempts to re-enroll a participant having an open placement in a previous enrollment, a task is sent to the grantee administrator of the prior enrollment notifying them that the placement needs to be closed. Once the placement end date has been entered by the previous grantee, the task will be cleared.
- The Date of Safety Consultation column in the PRA Report is populated with each participant's most recent Participant Safety Consultation Date.
- The field **Formerly Incarcerated** has been added to the detail of the Waiver of Durational Limit report.
- The **Provider** field is now a required field in a Training and Services record.
- The headings on the confirmation screen when a user generates the Internal and Nationwide QPRs have been changed to: **Internal QPR Report Generation Status** and **Nationwide QPR Report Generation Status**, respectively.
- A link has been added in the Results Summary of the Waiver of Durational Limit report that will generate a list of all active participants, not just those who are 396 days or less from their DLD.
- The **County** field on the Assignments summary page is now populated with the participant's county of residence, where available; otherwise, it is populated with the mailing address county.
- The **Is Family Income at or below 125% poverty level?** field on the Eligibility screen is now correctly reflecting the Poverty guidelines and income amount for participants with family members of 15 or more members.
- There are no longer any records associated with the sub-grantee RG999. They have all been moved to the correct sub-grantees.
- The authorized positions are available in the Equitable Distribution section of GPMS for program year 2024.
- The system displays a warning message when the number entered in the **Number in Family** field on the Eligibility screen is more than 14. Users have the option to confirm or reject the number entered.

Enhancements

- Users will not be able to enter a Transfer Effective Date that is earlier than the application or assignment date, or in between the assignment date and assignment end date.
- The system will no longer accept only spaces as a valid entry in the **Provided By** field on the PRA page.
- When a user attempts to add a participant that already exists in the system, the following message will be displayed: "Based on the Social Security # this person is currently enrolled with the following grantee: <Grantee Name>. Please contact your grantee" In addition, a new case cannot be added for participants with an active case in the system.
- The **Is Re-Enrolled** field now reflects the correct information for all subsequent enrollments.
- The contact address information in the Manage Organization and Contacts module is now being saved, and the primary contact's name is displayed only once on the UI.
- The Average Hours field has been removed from the UI on the Placement page.
- Total includable family income for Hawaii and Alaska now reflects the correct Poverty Level guidelines for 2022, 2023 and 2024 when editing an Eligibility record, or when creating/editing a Recertification record.
- The task "Durational Limit Extension is due <Case ID, Name>" has been removed from the system.

Known Issues

- The **Provider** field on the Add New Service screen for Supportive Services, or when editing an existing Supportive Services record, is now required. The field will be made optional in release 2.9.
- The "Due Date of Next Recertification" column is blank in the PRA report. This will be fixed in Release 2.9. In the interim, please use the following work-around to manually update the report. For each participant row:
 - o If there is a date in the "Date of Recertification" column, the value of "Due Date of Next Recertification" is that date+365 days.
 - o If there is no date in the "Date of Recertification" column, the value of "Due Date of Next Recertification" is the date in "Initial Assignment Date" +365 days.
