SCSEP GPMS

Release Notes – Version 3.0

Release Date: October 24, 2024

GPMS Release 3.0 addresses new features, and bug fixes discovered during the previous release.

New Features

- Users can now add a break for cases that have already exited. This addition can be done by all user roles except the read-only role.
- Users can now search by a participant's last and first name (format last name, first name) in the Participant Name field.
- Users will no longer be able to submit multiple new user requests prior to the expiration of the original submission.
- The titles on the Admin Console page are now 508 Compliant.

Fixes

- Formerly Incarcerated is now only editable in the Priorities of Service section of the Characteristics tab. The date field has been removed from the Most in Need section of the Characteristics tab, and on the Manage Waiver Factors page through Related Actions.
- There are no longer participants with multiple Active cases in the system. This condition had impacted the Waiver of Durational Limit (WDL) report where the numbers in the summary did not match the number of participants displayed in the pagination section of the Participant table.
- Extensions are now displayed in the UI for all the years an extension was granted to that participant. In addition, once an extension is added to a participant's record, the participant will no longer appear on the Manage Multiple Case Extension list.
- The **Due Date of Next Recertification** and **Date of Recertification** are now calculated correctly on the Participant Actions Report. In addition, the Summary tab of the report now shows the correct count of recert statuses that are displayed in the Details tab.
- Users will no longer receive an error message stating that the transfer effective date is before the application date for all records when transferring multiple cases.
- The Nationwide QPR can now be generated for Program Year 2024.
- The system now enforces a three-digit numeric code for Grantees and a maximum of ten alphanumeric characters for Sub-Grantee codes.
- Read-only users will no longer be able to create or edit cases.
- Users should now be able to see all participants in the search results based on filter(s) selected.

- The table names on the Participant Hours Report are now listed as: "Grantee Summary Hours Table" and "Case Summary Table"
- Changes to the Date of Birth field are now being saved in GPMS.
- After a record becomes locked, the Days Left in Program" is now consistent with the DLD.
- When waiver factors are updated via Related Actions, the dates for the respective factors are no longer simultaneously updating the Characteristics page.
- The Follow Up report now reflects all Expired follow ups for program years prior to PY2022.
- Users will no longer receive a task and notification for items that are already completed.

Known Issues

- The PHR export is duplicating assignments if the entire grantee is filtered. The workaround is to filter the report at the sub-grantee level. A fix is due in the next release.
- The Employment Rates (Q2 & Q4) are incorrect in Section B2 of the QPR. Grantees will be notified when a fix has been implemented.
