

SCSEP GPMS

Release Notes – Version 3.2

Release Date: January 24, 2025

GPMS Release 3.2 addresses new features, enhancements, and bug fixes discovered during the previous release.

New Features

- Selected grantees are participating in a pilot program. These grantees will select **Yes** for the field **Sector Demonstration Participant** of the **Pilot Program Enrollment** section on the **Intake** page. When validating records for participants who are included in the pilot program, the system will
 - Display a **Pilot Program Enrollment** section on the **Intake** page.
 - Validate the hours for Occupational Skills training (OST) and On-the-job Training (OJT). Negative numbers cannot be entered in these fields and the maximum number of hours allowed is 560 per quarter.
 - Display two new types – **Demo On-the-job Training (OJT)** and **Demo Occupational Skills Training (OST)**, when the **Education and training** category is selected on the **Add New Service** page.
 - Display an **Additional Fields** section when the **Type: Demo On-the-job Training (OJT)** is selected on the **Add New Service** page.
- Users will be able to edit the data on the **Add New Service** page. The date fields must be entered in the format **mm/dd/yyyy** otherwise, an error message will be issued stating that the date format is incorrect.
- The wage fields only accept numeric values. Entries less than \$7.25 will result in an error message stating that wages cannot be below \$7.25 per hour.
- The **Provider** field is mandatory in the **Training and Service** section for participants in the pilot program.
- If the option **7. Exited demonstration, remains in SCSEP: other reason** is selected when exiting the pilot program, the mandatory free-form text field **Reason for Exit Other** will become available for input.
- Existing cases will default to **No** at the **Sector Demonstration Participant** field on the **Intake** page.
- **NOTE:** Grantees who do **not** have a demonstration grant should **always** select **No** at the **Sector Demonstration Participant** field on the **Intake** page. Demonstration grantees will receive guidance via a separate email. They should select **No** in the **Sector Demonstration Participant** field until they have completed the training in late February and receive approval from their research team site liaisons to begin enrolling participants.
- Grantee Administrators can now submit their Quarterly Progress Reports (QPRs) to Workforce Integrated Performance System (WIPS) when instructed. However, they will

not be able to download the raw Participant Individual Record Layout (PIRL) files during the WIPS submission.

- Existing tasks with a case status of **Withdrawn** are now being deleted from the backend.
- The entries made on the Add New Service screen can be edited after the original entry is saved.
- When a case is withdrawn, the exit-related data will be updated accordingly.
- When the **Participant Safety Consultation** date is deleted, the deleted information will no longer appear in the UI.

Enhancements

- The navigational path Admin Console -> Manage Grantees -> Manage Grantee / Subgrantee has been removed from GPMS. Subgrantee information can be obtained from the **GRANTEE** module.

Fixes

- Users can now enter dashes in the **Fax Number** field on the **Organization Details** page.
- GPMS now accepts commas (,) in the **Organization Name** field, on the **Organization Details** page.
- The Right of Return (ROR) in GPMS is now permitted if the date is exactly the 90th day after exit.
- The edit restriction on the Date First Active field in the Sub-Grantee Status section has been removed, allowing users to enter any date in this field. This field is no longer linked to the application date of participants within a Sub-Grantee.
- When cases are transferred, all assignments are successfully transferred to the recipient grantee.
- GPMS will not accept an applicant's signature date if it is earlier than the application date.
- The Due Date of Next Recertification and Date of Recertification is now correct in the Participant Action (PRA) report.
- Cases will only be locked if an exit date is not entered in GPMS seven or more days after the Durational Limit Date (DLD).
