

# SCSEP GPMS

## Release Notes – Version 3.4

---

**Release Date: April 11, 2025**

GPMS Release 3.4 addresses new features, enhancements, and bug fixes discovered during the previous release.

### New Features

- Users with the role of Grantee Administrator can view a participant's transfer and move history from the ADMIN CONSOLE via the card **View Transfer/Move History**.
- Users can be added as a watcher to a ticket in the Help Request Module (HRM) by selecting the **Start Watching Request** under **Related Actions**.
- Users who exited the program prior to July 1, 2007, should now be able to re-enroll in the program for the full four years.
- Users can now create custom default filters on the Cases page.
- **Placement-Expected Hours** per week is restricted to 99 hours or less.

### Enhancements

- When a new case is being created, the system automatically populates the field **Pilot Program Enrollment; Sector Demonstration Participant** to “No” on the Intake page. Additionally, existing cases that had blank in this field have been set to “No”. This field is also editable by the user.
- The label on the **ADD SERVICE** page has been changed from Service Provider to Provider.
- Users will now only see the Grantees and Sub-Grantees to which they are assigned in the Internal QPR dropdown menu.
- End users of the Help Request Module (HRM) will not be able to close the tickets they created. Tickets can only be closed by the SCSEP Help team.
- The Assignment by Host Agency Report has been redesigned to be more efficient, allowing the report to handle large volumes of data accurately and users will not receive a UI error when the **Show Most Recent Assignment Only** filter is selected. Additionally, the report has been updated to reflect the correct information in the Length of Assignment field. The report is now showing the correct count for active participants and the average number of participants in the summary and export.
- The job code is now listed alphabetically on the assignment, services and placement pages.
- The Current/Exited report has been updated to include the job code and CSA title on the export.

- Cases that are currently on the waiting list, the eligibility date is displayed in the **Waitlist Date** column.
- When a participant is searched via Admin Console, information related to all cases should appear when user clicks the linked participant's name.
- The **Grant Number** text box has been removed from the **Co-Enrollment in National Farmworker Jobs Program?** field.
- Roman numerals have been added on the Add Service screen for assignments, when the **Supportive Services category** is chosen.
- In the Referral Details section, when the Referral Outcome is **Referral Service not Received**, then Service Details and Additional Fields will not be displayed.

## Fixes

- The urban/rural values for participants who are either Active or Exited Closed/Exited in Follow Up having an exit date on or after 7/1/2024 to reflect the latest urban/rural values available.
- Users will no longer be able to enter overlapping breaks in GPMS.
- An invalid message will no longer be displayed when editing OJT and OST in add assignment service.
- Edits to the mailing address is now being saved in the system.
- The case status will no longer be changed to withdrawn when user selects Withdraw from cases page and clicks Cancel on confirmation page. The case status remains **Eligible**.
- The date fields for Assignments, Breaks, Training/Services no longer switch over to text fields as the date fields are being edited.
- Entries are no longer required in the comments field of the transfer bulk upload excel file.
- Users are no longer able to add, delete or edit approved breaks in transferred assignments.
- Users will no longer be able to add a new open assignment with an assignment date earlier than the existing one.
- The data in the **Eligible to Enroll** field is now in sync on the Participant Search from the Admin Console and **Participant Summary** on the **Cases** page.
- After a social security number (SSN) is updated and existing cases are merged, users will be able to search using the updated SSN on the Add New Case page and from the Participant Search on the Admin Console.
- Users will not be able to enter an exit date after the DL date for any exit reason.
- Users will no longer receive an error message after clicking the linked number at the **Durational Limit for all Active Participants:** field on the Waiver of Durational Limit Report.
- The number at the **Day(s) Left in Program** field is in sync on all screens and GPMS.
- The edited data in the **Pre-Assessment Date** and **Program Overview Date** is now being retained when the save button is selected.
- For locked cases and cases that exited for DLD, the **Month(s) in Program** is being calculated through the DLD and not the current date.
- Users will no longer receive a notification to update the physical exam information in GPMS if it has already been updated.
